**PROPERTIES:** KEYMIX® KEY-VITA-MIN™ is formulated to adequately supplement the vitamins and minerals that are likely to be deficient or marginal in the ingredients commonly used in poultry rations. The adequacy and balance of these nutrients are essential to maintain the health and productivity of all birds. The role of minerals and vitamins is to improve the nutritional value of feed by supplementing those nutrients, which are missing or low in commonly used feed. Intensively raised livestock are by definition almost entirely hand fed and dependent on supplied feed. Therefore, every attempt is made to guarantee the balance and potency of vitamins and minerals in the feed.

Boosting vitamin and mineral intake with administration of well-balanced vitamin and mineral preparations is a common and useful practice in the poultry industry for many reasons. Stress is an intrinsic component of intensive systems that can be reduced if birds are provided with a balanced diet to maintain their appetite, health and resistance to disease. Certain practices and life-cycle periods in all livestock are clearly associated with stress for example, handling, introduction to new feed regimes, vaccination, regrouping, transport and laying/breeding.

**DOSAGE AND ADMINISTRATION:** Add 625 g of KEY-VITA-MIN to each tonne (1,000 kg) of balanced ration. To achieve even distribution through the feed, first mix the KEY-VITA-MIN well into 5 kg of a fine ingredient (e.g. pollard or wheatmeal) before adding to the bulk of feed. Introduce this premix early in the mixing process.

**WITHHOLDING PERIODS: (MEAT & EGGS): NIL.**

**TRADE ADVICE:** EXPORT SLAUGHTER INTERVAL (ESI): ESI not required.
